**Childcare Program - The YMCA offered afterschool programs, which included transportation to the facility from most area schools. Afterschool programs focused on the YMCA core values of Caring, Honesty, Respect and Resonsibility, while providing a safe and structured environment for children in the community. The summer program offered daily specialty camps that focused on individual interests, such as sports, arts and crafts and games. The YMCA also offered a specialty camp focusing on gymnastics. All summer programs included a free breakfast and lunch for participants, weekly field trips and swimming. The YMCA READS! program was offered in both Alachua and Bradford County, and offered free tutoring for students in grades K-3, who are reading below grade level and were identified by their**
